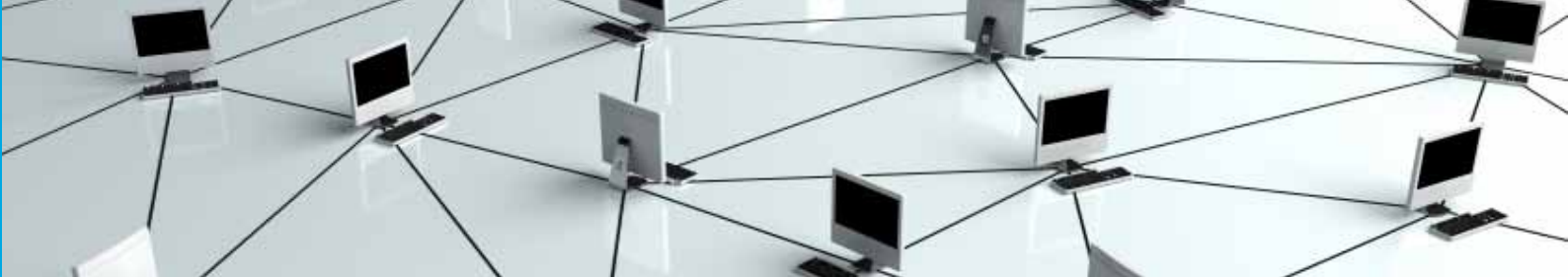

Banks and IT partners who have made significant IT changes in their institutions in Asia Pacific are encouraged to apply for these awards. The evaluation criteria will be rigorous and the final selection will be done by a panel of industry experts.

Please note that not all awards are made every year for the categories that exist. Our choice of awards to be made in any one year depends on the quality of the submissions received and the benchmarks set by the submissions for the rest of the industry in that year.

We do modify the awards over the years to recognize the changing face of the industry and the new technology innovations as they evolve.

Please also note that awards are only made for COMPLETED PROJECTS, and not projects that are still under implementation. Actual, not projected, performance matrix are an important consideration for these awards.

MAKING YOUR SUBMISSION

2.1. Who is eligible?

Banks and their IT partners need to jointly apply for the award. All banks and non-bank financial institutions (including insurance companies, brokerages, credit companies and finance companies) with operations in Asia Pacific countries, which have completed Technology Implementations in 2010 are eligible for submission. Separate submission from banks and IT companies will not be entertained.

2.2. What documents do I need to submit?

You need to fill the questionnaires I and II and provide all relevant details of the implementation project. Your submission should be accompanied by one copy each of your institution and IT partner's latest annual report.

If you would like to apply for more than one category, please answer the questionnaires separately for each award's category applied for. One annual report is adequate for multiple category submissions.

2.3. Will institutions that do not make a submission be considered?

For IT projects of outstanding merit The Asian Banker may decide, at its own discretion and on a strictly case by case basis, to consider institutions that do not make a submission. However, institutions that do not make a submission may have a ranking that is not up to their expectations due to unavoidable difficulties in gathering full and accurate information when a submission has not been made.

2.4. Is the information submitted made available to the public?

All business sensitive information provided will not be published in any form whatsoever that could reveal the names of the institutions involved. The information selected for determining industry benchmarks will not refer to any institution by name.

2.5. What is the deadline for submissions?

To be considered for an Award, please make a complete submission to us no later than 14 January 2011, preferably in electronic format. Please keep in mind that only IT projects that were completed or made fully functional in 2010 are eligible for consideration.

Stage I : First Review

4 February 2011

Each complete submission is reviewed and scored by a team of analysts. Shortlisted teams are notified.

Stage II : Interviews

February-March 2011

Based on the independent review, our team of analysts will interview short-listed teams in the respective categories. Interviews will be conducted with the relevant people involved in the project.

Stage III : Selection and Notification of Award Winners

15 March 2011

Based on submissions and interviews our international panel of judges will select the winners for each category.
