Bareksa enabled its users to invest with ease through new innovative features

Bareksa rolled out its innovative features called "auto sweep" where incoming fund in the user's e-wallet will go directly into the user's mutual fund account and "automatic redemption" that enables immediate availability of fund when they purchase goods. The collaboration with the big local e-commerce players enabled Bareksa to position itself in the forefront as investment platform along with investment information for many Indonesians.

The platform has witnessed a growth of 460% in the value of funds invested

The platform has a notable coverage with 160 products from 33 asset management companies. The value of funds invested through the company has risen exponentially. It witnessed a growth of 460% in funds invested in 2017 and hit a milestone of 1 trillion IDR (\$68.6 million) for the value of funds invested through its platform for the first time in the first half of 2018. The number of mutual funds users at the platform has grown by over 800% in 2017.
