## Fidessa wins Trading Platform of the Year in 2015

- Superior financial performance

**Hong Kong, April 15<sup>th</sup>2015 – Fidessa** has been named as winner for the **Trading Platform of the Year** award 2015 during The Asian Banker Financial Markets Awards Programme. #### **Superior financial performance**

#### Addition of its first Vietnamese broker, VN Direct

Fidessa has also added its first Vietnamese broker, VN Direct, to its connectivity network. Members of Fidessa's global trading and investment community can now access the Vietnamese market directly, or with the support of VN Direct's specialist execution capabilities. The move represents an important milestone in electronic trading in Vietnam, enabling automated, real-time execution of Vietnamese orders via a standardised FIX protocol and stripping out the inefficiencies associated with manual trading processes.

The awards programme, administered by The Asian Banker and refereed by prominent global bankers, IT consultants and academics, is the most prestigious of its kind. A stringent three month long evaluation process determined the winners from across Asia Pacific, Middle East and Africa. The winners were honoured at a gala event that recognized their efforts in using the best technology to run their institutions and bring superior products and services to their customers
